2. Vendor shall pay its non-refundable fee at time of enrollment.
3. Only items listed in a vendor's application may be displayed. Guns, fireworks, sexually explicit, and/or other conduct deemed offensive by the event managers in their sole discretion are prohibited and must be removed immediately. Vendor shall comply with all rules and regulations of the event managers as are adopted from time to time.
4. Vendor shall at all times keep the space free of hazards, and occupy the space in a safe and clean manner.
5. Vendor shall clean up the space and its immediate surrounding area at the end of the event.
6. The event managers, including Meriwether Place, Dianna's Formal Affair, its employees, and representatives, shall not be responsible for any loss or damages, of whatever kind, arising out of vendor's activities at this event. Vendor assumes the entire risk of loss from its activities. Prior to occupying the space, vendor should consider obtaining their own insurance.
7. Vendor shall comply with all laws, rules and regulations and shall obtain all necessary permits, relating to its activities and the conduct of its operations at the event. **No smoking on premises.**
8. Vendor shall defend and hold managers completely harmless from any loss or damages of whatever kind, arising from vendor's activities at the event, Vendor shall on demand reimburse the event and the managers for any expenses incurred as a result of vendor's failure to perform this agreement.
9. Vendor is expressly prohibited from subleasing rented space(s).
